Sub: Consolidated Scrutinizer's Report on Remote E-voting of 27th AGM of Hilltone Software & Gases Limited (the 'Company')

I, D. A. Rupawala, Proprietor of M/s D.A. Rupawala & Associates, Chartered Accountants, have been appointed as Scrutinizer by the Board of Directors of M/s. Hilltone Software & Gases Limited (the Company), pursuant to Section 108 of the Companies Act, 2013 ("the Act") to scrutinize the remote e-voting process of 27th Annual General Meeting of Equity shareholders of M/s. Hilltone Software & Gases Limited held on Tuesday, 29th September, 2020 at 03:30 P.m. through VC/ OAVM. I submit my report as under:

- (i) The Company has provided remote e-voting facility offered by National Securities Depository Limited (NDSL) for casting the votes electronically by the shareholders of the company.
- (ii) The shareholders of the Company holding shares as on the "cut-off" date i.e. on 21st September, 2020 were entitled to vote on the resolutions as set out in the Notice of the 27th AGM.

(iii) The voting period for remote e-voting commenced from Thursday, 24th September, 2020 at 10:00 a.m. and concluded on Monday, 28th September, 2020 at 5:00 p.m. and thereafter the NDSL remote e-voting platform was blocked.

- (iv) After the completion of the e-voting process, the votes cast through remote e-voting facility were unblocked and downloaded from the e-voting website of NDSL (https://www.evoting.nsdl.com/) in the presence of two witnesses, who are not in the employment of the Company.
- (v) I have scrutinized and reviewed the remote e-voting and votes cast therein based on the data downloaded from the NDSL e-voting system.

The management of the Company is responsible to ensure the compliance with the requirements of the Act, Rules, circulars issued from time to time relating to voting through electronic voting system on the resolutions as set out in the Notice of the 27th AGM of the Members of Company. My responsibility as a Scrutinizer for the remote evoting is restricted in making a Scrutinizer's Report of the votes cast "IN FAVOUR" or "AGAINST" on the resolutions stated in the Notice, based on the reports generated from the e-voting system of NDSL, the authorized agency engaged by the Company.
